

# OFFICIAL RULES

## #LOBONITODEDAR CONTEST FROM REMMESA

**1. PROMOTION PERIOD:** The #LoBonitoDeDar Social Contest from Remmesa (“Promotion”) shall run on the dates during the times (“Promotion Period”) in the Promotion Details as follows:

**2. SPONSOR AND ADMINISTRATOR:** For purposes of these Official Rules, “Remmesa” shall mean Remmesa, Inc. (“Sponsor”). The Promotion is administered by Flowers Communications Group or a successor designated by Sponsor (collectively referred to as “Administrator”).

**3. AGREEMENT TO THE OFFICIAL RULES:** By participating in the Promotion, all participants fully and unconditionally agree to and accept these Official Rules and the decisions of the Sponsor and Administrator as final and binding in all matters related to the Promotion. Winning a prize (described below) is contingent upon fulfilling all requirements set forth herein.

**4. HOW TO ENTER:** Entrants must visit [LoBonitoDeDar.com](http://LoBonitoDeDar.com) during the Promotion Period and confirm the legal ability to enter the contest. To be qualified, entrants must be legal residents of the United States age 18 or over. Entrants will be prompted and must download the Remmesa app for Android or iOS, then complete the Entry Form.

Participation is limited to one (1) entry per person. Sponsor and Administrator will assume no responsibility for lost, mutilated, late, stolen, or misdirected entries.

**5. ODDS:** Odds of winning one of the prizes set forth in Section 7 of these Official Rules depend on the total number of eligible participants during the Promotion Period.

**6. ELIGIBILITY:** The Promotion is open only to individuals who, at the time of entry, are legal United States residents at least 18 years of age. In addition, the following persons are not eligible to enter this Promotion nor claim a prize: (a) the employees, officers, directors, partners, equity holders, members, and agents of Remmesa or Pangea USA, LLC, and each of their respective parents, subsidiaries, advertising and promotion agencies, and affiliates; (b) officers

and employees of Sponsor or Administrator; (c) officers and employees of advertising, public relations, and sales promotion agencies employed by Remmesa who are directly involved in the Promotion; (d) officers and employees of audit firms performing services for Remmesa; (e) other contractors and agents of Remmesa and Pangea USA, LLC; and (f) any spouse, child, or family member residing as a member of the same household in the principal place of residence of any person designated in (a) through (f) above. This Promotion is void where prohibited by law.

## 7. PRIZES AND THE VALUE OF THE PRIZES:

**One (1) Latin America Trip Prize:** Each Latin America Trip Prize winner will receive one (1) trip for 4 (four) persons for 4 (four) nights to 1 (one) Latin American destination from Exhibit 1 (“Latin American Destinations”) attached to this document; flight operators, accommodations, and/or gift cards for travel shall be selected by the Administrator (“Latin America Trip Prize”). The prize shall include 4 (four) round-trip economy class or higher flights originating in the United States and 2 (two) double-occupancy hotel rooms for 4 (four) nights OR airline and hotel vouchers of comparable value selected by the Administrator. Subject to availability, Remmesa shall award a maximum total of one (1) Latin America Trip Prize. Prizes are subject to Remmesa’s terms and conditions. The approximate retail value (“ARV”) of each Latin America Trip Prize is \$5,000.00.

**Two (2) Artist Meet & Greet Prizes:** Each Artist Meet & Greet Prize winner will receive one (1) virtual meet and greet session of 15 (fifteen) minutes with an artist selected by the Administrator (“Artist Meet & Greet Prize”). Subject to availability, Remmesa shall award a maximum total of two (2) Artist Meet & Greet Prizes. Prizes are subject to Remmesa’s terms and conditions. The ARV of each Artist Meet & Greet Prize is \$500.00.

**Twenty (20) \$50.00 Remmesa Voucher Prizes:** Each \$50.00 Remmesa Voucher Prize winner will receive one (1) \$50.00 Remmesa Voucher, Gift Card or Promotional Code, selected by the Administrator (“\$50.00 Remmesa Voucher Prize”). Subject to availability, Remmesa shall award a maximum total of twenty (20) \$50.00 Remmesa Voucher Prizes. Prizes are subject to Remmesa’s terms and conditions. The ARV of each \$50.00 Remmesa Voucher Prize is \$50.00.

The dates and times of the Promotion may be subject to change and cancellation. The winner and guest(s) agree to comply with all applicable rules and policies in connection with the prizes. The Sponsor and Administrator have the right to remove or to deny entry to any winner or guest who engages in an unsportsmanlike or disruptive manner, or exhibits an intent to annoy, abuse, threaten, or harass any other person in relation to the Promotion. Any comments made by a winner in a social media format containing material that is inappropriate, offensive, indecent, obscene, hateful, tortious, defamatory, slanderous, or libelous may disqualify the winner, at Sponsor’s sole discretion. The Promotion Entities (defined below) will not be responsible for

acts of God, acts of terrorism, civil disturbances, work stoppage, or any other natural disaster outside their control that may cause the cancellation or postponement of the Promotion. All other expenses and costs, not expressly listed above, including, but not limited to, federal, state, and local taxes, parking, and ground transportation are the winners' sole responsibility. All travel risks, insurance, loss, or damage due to prize acceptance or use are the sole responsibility of the winners. Neither the Promotion Entities nor their affiliates or subsidiaries will be responsible for any loss, liability, or damage arising out of a winner's acceptance or use of a prize.

**8. WINNER SELECTION AND NOTIFICATION TO PRIZE WINNERS:** All of the prize winners will be determined within 2 (two) weeks from the end of the Promotion Period via random selection. Winners will be notified via the contact information provided on his or her contest entry form. All winners must respond to winner notification within 72 hours or the winner will forfeit the prize and the Administrator will select an alternate winner. Winners may need to complete an affidavit and/or 1099 provided by the Administrator in order to claim prizes.

**9. GENERAL PRIZE RESTRICTIONS:** Prizes are subject to availability and change. No substitution or cash redemption allowed by winners. No cash equivalent of the prizes will be awarded, and the prizes are not exchangeable or otherwise transferable. Latin America Trip Prize must be booked by May 15, 2021 and travel completed no later than January 31, 2022. Latin America Trip Prize travel for all 4 (four) travelers must be redeemed simultaneously (i.e. Administrator will not book multiple trips). Promotional Codes are valid only for users that live in a state in which Pangea operates. Sponsor reserves the right to substitute the prize in whole or in part with other prizes of comparable or greater value, if the intended prize is not available for any reason, as determined by the Sponsor in its sole discretion. Unless explicitly outlined in Section 8 of these Official Rules, the winners will be exclusively and solely responsible for travel to and the costs thereof, and all other costs and expenses associated with prize acceptance and use not described as being provided, including but not limited to parking expenses, gratuities, and other expenses incurred by accepting a prize. This Promotion is governed by and shall be construed in accordance with Illinois law and is subject to all applicable federal, state, and local laws and regulations. Any and all taxes, including but not limited to federal, state, and local taxes, are the exclusive and sole responsibility of the winner. Each winner may be required to provide his or her Social Security number and appropriate tax documentation for tax reporting purposes. If required, the Administrator will file an IRS Form 1099 or similar document with the Internal Revenue Service for the fair market value of any prize.

Prizes may not be resold or offered for resale or used for any commercial or promotional purpose whatsoever. Any such resale or commercial or promotional use may result in disqualification and prize forfeiture.

**10. GENERAL CONDITIONS AND RELEASE:** The Promotion is subject to applicable laws and regulations. By entering, each entrant (a) agrees to defend, indemnify, release, and hold harmless the Sponsor and Administrator (collectively the “Promotion Entities”), and each of their respective owners, parents, affiliates, subsidiaries, directors, officers, agents, employees, managers, licensees, distributors, dealers, retailers, printers, representatives, advertising and promotion agencies, and any and all other companies associated with the Promotion, and all of their respective officers, directors, employees, agents, and representatives (collectively, the “Released Parties”) from and against any and all claims, causes, costs, injuries, losses, or damages of any kind that may occur, directly or indirectly, in whole or in part, arising out of the entrant’s participation in this Promotion or receipt or use of any prizes, including, but not limited to: (i) unauthorized human intervention in the Promotion; (ii) technical errors related to computers, servers, providers, or telephone or network lines; (iii) printing errors; (iv) lost, late, postage-due, misdirected, or undeliverable mail; (v) errors in the administration of the Promotion or the processing of entries, including but not limited to data entry errors resulting from or caused by the entering, keying, or mis-keying of the required information by entrants; (vi) injury or damage to persons or property that may be caused, directly or indirectly, in whole or in part, from entrant’s participation in the Promotion or receipt or use of any prize; (vii) the unauthorized or illegal access to personally identifiable or sensitive information or the acceptance, possession, use, or misuse of any prize or any travel or activity related to the receipt or use of any prize; (b) grants Remmesa, Sponsor, and each of its respective designees a worldwide, royalty-free, perpetual, irrevocable, non-exclusive right and fully licensable license to use, copy, reproduce, distribute, publish, publicly perform, publicly display, modify, adapt, translate, archive, store, and create derivative works from entrant’s post (including any images) in whole or in part, in any form, format, or medium, of any kind now known or later developed; (c) if selected as the winner, consents to the use by Remmesa, Sponsor, and each of its respective designees of the winner’s name, hometown, photograph, voice, or other likenesses and prize information for promotion, advertising, and marketing purposes in any media or format now known or hereafter devised, throughout the world, in perpetuity, without additional compensation, consideration, notification, or permission, unless prohibited by law, and upon request will provide written confirmation of such consent; and (d) acknowledges that relative to any prize including, but not limited to, its quality or availability, none of the Promotion Entities or anyone else has either made, or is in any manner responsible or liable for, any warranty, representation, or guarantee, either expressed or implied, in fact or in law, including without limitation the implied warranties of merchantability, fitness for a particular purpose, and non-infringement.

None of the Promotion Entities nor any of their service providers are responsible for incorrect or inaccurate transcription of entry information; any human or other error, technical malfunctions; lost or delayed data or voice transmission; omission; interruption; deletion; defect; line failures of any telephone network, computer equipment, or software; inability to access any online service or website or to complete a telephone call or facsimile transaction; any other error or

malfunction; late, lost, or misdirected mail; or any injury or damage to an entrant's or any other person's computer related to or resulting from participation in this Promotion.

None of the Promotion Entities, nor their agents and representatives, owners, parent companies, affiliates, subsidiaries, advertising, promotion and fulfillment agencies, and legal advisors are responsible for or liable for: (a) late, lost, damaged, misdirected, misaddressed, incomplete, unintelligible, illegible or postage due entries; (b) telephone, electronic, hardware or software program, network, internet or computer malfunctions, failures or difficulties of any kind; (c) failed, incomplete, garbled, or delayed computer transmissions; (d) any condition caused by events beyond the control of Sponsor that may cause the Promotion to be disrupted or corrupted; (e) any injuries, losses, or damages of any kind arising in connection with or as a result of the Promotion, acceptance, possession, or from participation in the Promotion; (f) any printing or typographical error in any material associated with the Promotion; (g) any other errors, problems or difficulties of any kind whether human, mechanical, electronic, network, computer, telephone, wireless service, mail, typographical, printing or otherwise relating to or in connection with the Promotion, including, without limitation, errors or difficulties that may occur in connection with the administration of the Promotion, the processing of entries, the announcement of the prizes, or in any Promotion-related materials; or (h) any incorrect or inaccurate information, whether caused by website users, tampering, hacking, or by any equipment or programming associated with or utilized in the Promotion.

Sponsor reserves the right, in its sole discretion, to cancel the Promotion in its entirety, if it becomes technically corrupted or because of non-authorized human intervention. If any discrepancy should exist between these Official Rules and any promotional material describing this Promotion, these Official Rules shall govern.

**CAUTION:** ANY ATTEMPT BY AN ENTRANT OR ANY OTHER INDIVIDUAL TO DAMAGE ANY WEBSITE ASSOCIATED WITH THIS PROMOTION, TAMPER WITH THE ENTRY PROCESS, OR OTHERWISE UNDERMINE THE CONTENT OR LEGITIMATE OPERATION OF THE PROMOTION MAY BE A VIOLATION OF CRIMINAL AND CIVIL LAWS AND SHOULD SUCH AN ATTEMPT BE MADE, SPONSOR WILL DISQUALIFY ANY SUCH ENTRANT, AND SPONSOR AND THE APPLICABLE PROMOTION ENTITIES AND THEIR RESPECTIVE AGENTS RESERVE THE RIGHT TO SEEK DAMAGES (INCLUDING ATTORNEYS' FEES) AND OTHER REMEDIES FROM ANY SUCH ENTRANT OR INDIVIDUAL(S) RESPONSIBLE FOR THE ATTEMPT TO THE FULLEST EXTENT PERMITTED BY LAW.

No failure to enforce any term of these Official Rules shall constitute a waiver of that provision. These Official Rules may be modified for clarification purposes without materially affecting the terms and conditions of the Promotion. Entrants not complying with all rules are subject to

disqualification and an alternate winner will be selected from among all eligible, non-suspect entries received as of the time of such disqualification, as the Sponsor or Administrator determine in their sole discretion. If for any reason the Promotion (or any portion thereof) is not capable of being executed as planned, or in the case of infection by computer virus, bugs, tampering, unauthorized intervention, fraud, action of entrants, technical failures or any other causes, that in the opinion of Sponsor or Administrator corrupt or affect the administration, security, fairness, integrity, or proper conduct of this Promotion (or any portion thereof), Sponsor and Administrator reserve the right in their sole discretion to disqualify any suspect entry or entrant and/or to cancel, terminate, modify or suspend the Promotion (or any portion thereof). In the event of any termination, cancellation, or suspension, notice thereof will be posted on the Remmesa website (<http://www.Remmesa.com>).

**11. APPLICABLE LAWS:** All entrants agree to comply with and abide by all applicable laws, administrative rules and regulations, instructions, conditions and final decisions of Remmesa and all procedures established by the Sponsor and the Administrator for the Promotion. In the event of a conflict between these Official Rules and any summary, representation, or other restatement of rules appearing in any advertisement, point of sale material, tickets or other media, these Official Rules shall govern.

**12. DISPUTE RESOLUTION:** Except where prohibited by law, by entering, Promotion entrants agree that in the event of a dispute concerning the construction, validity, interpretation, or enforceability of these Official Rules, the determination of Remmesa shall be final and binding. All issues and questions concerning the rights and obligations of participant(s) in relation to Sponsor, Administrator, and their agents shall be governed by and construed exclusively in accordance with the laws of the State of Illinois without giving effect to any principles of conflicts of law of any jurisdiction. Entrant agrees that any such action at law or in equity shall be filed only in the state or federal courts located in Chicago, Illinois, and entrant hereby consents and submits to the personal jurisdiction of such courts for the purposes of litigating any such action. EXCEPT WHERE PROHIBITED BY LAW, BY PARTICIPATING IN THIS PROMOTION, EACH ENTRANT AGREES THAT: (A) ANY AND ALL DISPUTES, CLAIMS, AND CAUSES OF ACTION ARISING OUT OF OR CONNECTED WITH THIS PROMOTION, OR AWARDING OF THE PRIZES, SHALL BE RESOLVED INDIVIDUALLY, WITHOUT RESORT TO ANY FORM OF CLASS ACTION; AND (B) ANY AND ALL CLAIMS, JUDGMENTS, AND AWARDS SHALL BE LIMITED TO ACTUAL OUT-OF-POCKET COSTS INCURRED, INCLUDING COSTS ASSOCIATED WITH PARTICIPATING IN THIS PROMOTION BUT IN NO EVENT ATTORNEYS' FEES; AND (C) UNDER NO CIRCUMSTANCES WILL ANY PARTICIPANT BE PERMITTED TO OBTAIN AWARDS FOR AND HEREBY WAIVES ALL RIGHTS TO CLAIM PUNITIVE, MULTIPLIED, INCIDENTAL, AND CONSEQUENTIAL DAMAGES; OR ANY OTHER DAMAGES, OTHER THAN FOR ACTUAL OUT-OF-POCKET EXPENSES.
